## **POLICE REPORT:**

Lambert reported 2,654 calls for service for January.

- There were 4 code violations resolved.
- There were 3 Breaking & Entering Larcenies.
- Badin Police Department participated with the Stanly County Sheriff's Department in the roundup. There were 31 arrests made with 7 being from the Badin area.
- Badin Police Department is now accepting Part-Time Police Officer applications.

## **PUBLIC WORKS:**

Carter reported the following:

- Public Works collected 11 loads of brush for February.
- Last round of Leaf Collection began February 13<sup>th</sup>.
- West Badin Park mulch project is complete.
- 4 Crape Myrtle trees were planted along sidewalk along Roosevelt Street.
- Next limb/brush collection will be March 7<sup>th</sup>.

## **FINANCIAL REPORT:**

Almond presented the financial report for period ending February 10, 2017. Almond reported January Revenues came from Property Tax, Sales & Use Tax, and Occupancy Tax.

Willow Street Project will begin soon. Town should receive half its Powell Bill in January and half in October for an approximate annual total of about \$50,000 - \$56,000.

Possible accounts for festival sponsorship would be Special Events in Parks and Recreation, and Advertising/Tourism.

## **MANAGER'S REPORT:**

Almond reported the following:

- For Badin water system project updates visit <http://www.co.stanly.nc.us/>. Stanly County Utilities encourages residents to sign up for Blackboard connect notices from the utilities department for periodic updates.
  - The installation phase of the Greater Badin Water & Sewer District water system replacement project is 99 percent complete. Only 2 spots left, one being behind the town hall. Restoration phase has begun.
- Chambers and Hatley will attend the Stanly County CVB meeting 8:30 a.m. Wed., March 8<sup>th</sup> in the CVB meeting room of the Stanly County Commons in Albemarle.
- Stanly County will host the next COG meeting at 6:30 p.m. Tuesday, February 28<sup>th</sup> in the Partnership Meeting Room of the Stanly Commons located at 1000 N. First Street in Albemarle.
- Town Hall Day 2017 is at 10 a.m. Wednesday, March 29<sup>th</sup> in the LGFCU Conference Center in Raleigh. North Carolina Black Elected Municipal Officials (NCBEMO) Breakfast in the same day.
- 5 Red Maples will be planted along new Safe Routes to School sidewalk.
- Almond will attend a COG workshop for economic development.
- Dollar General Store construction is accelerating.
- Keep Stanly Beautiful grant was used to plant streetscape trees on Roosevelt St.
- Almond would like input from council and staff regarding restoration issues from the water project throughout town.
- Budget Retreat may be April 29<sup>th</sup>.
- The next Regular Council Meeting is scheduled for 7 p.m. Tuesday, March 14<sup>th</sup>, in Badin Town Hall.
