**PUBLIC COMMENTS**

Badin Police Chief Bryan Lambert stated all 7 Badin Law Enforcement Officers are opposed to placing a memorial monument on public property as requested by Mike Edgerton.

Badin Volunteer Fire Department Chief Terry Eudy stated that all 33 members of the Fire Department are 100 percent opposed to a memorial being placed on public property as requested.

Stanly County Sheriff George T. Burriss requested council deny the memorial request.

Milano said he stands behind Badin Law Enforcement and Badin Volunteer Fire Department. He apologized for his previous vote for a public memorial and would like to rescind his vote.

Chambers said she is very protective of town property and after prayer and consideration she believes council was hasty in their approval and would like to rescind her vote for memorial.

Council discussed the recent request for a memorial on public property. Lambert stated the State Bureau of Investigation (SBI) will go to the Stanly County District Attorney (DA) first with a presentation of evidence compiled by their experts. He said the DA will render a decision on whether or not there is cause for prosecution based on all available evidence.

Motion to rescind approval of Mr. Edgerton's request for a memorial on town property.

Milano said the family should be reimbursed by the town if purchases have been made for the requested memorial. Hatley said he does not believe council will discover anything from the SBI report which would cause council to reconsider approval of a public memorial. Mayor Harwood mentioned considering creating a program for memorials to establish uniform guidelines going forward.
