PUBLIC COMMENTS

Jody Hopper complained citizens don't always have all questions answered in council meetings.

Sherrill Mullis mentioned drain outlet on Alcoa property and confirmed with Alcoa the town can request forms to seek permission to clear the outfall. Mullis noted awareness of water issues elsewhere in town.

Dale Ward repeated support for replacement of the concrete block, colloquially referred to as the "deadman," which was removed from the Falls Road NC 740 median during demolition of the dilapidated asphalt median and prior to installation of a new concrete planter median.

Jerome Scott Miller of NCDOT, and Lee Snuggs of Rocky River RPO introduced themselves. They will introduce project request items to the state this fall. Funding is competitive but encouraged council to let them know by Sept. any requests they would like sent. There are spot safety improvement funds for smaller projects. Milano asked Miller about criteria to request road widening. Milano would like Valley Drive and Hwy 740 widened. Miller suggested sending these specific roads to his email so he can look into it. Milano also asked Miller to look at curb on Falls Road at the intersection of Hwy 740. Miller stated that density, safety, and congestion are issues that will send projects to the top of DOT's list.

Brenda Layberger said she weed-eats a ditch in her front lawn but is less able now and feels the town should do it for her.
