CALL TO ORDER

Mayor Huntley called the meeting to order.

Discussion: Town council explained decisions made in the special called meeting regarding the updated minimum housing ordinance to the members who were absent.

BUSINESS

Town Council considered a special event application for the Stanly County Special Olympics Polar Plunge March 8 in Badin Waterfront Park. They need an updated certificate of insurance and council suggested the location may be infeasible due to park construction. C. Council suggested they find an alternate site. Council will discuss the application in the next meeting.

Institute for Building Technology and Safety (IBTS) recommended updates to Town of Badin Minimum Housing Standards Ordinance 05-6 for municipal housing code enforcement. Following review of proposed changes, council consensus from Jan. 7 special called meeting was for two text amendments: 1) limit the time a property may be boarded from indefinitely, to two years, and 2) format document for ease of use.

Council adopted members and alternates to town advisory boards in December, tabling appointment of Board of Adjustment alternate. Nominee hasn't expressed interest. Almond recommends council offer additional nominees.

PUBLIC WORKS:

Eudy reported the following:

- Next limb/brush collection February 4, 2025.
- 5 Loads of brush for November.

Council reviewed new pole lights. If purchased in January town gets a 33% discount. Total of 22 lights needed. Ward recommended pricing 11 wreaths and 11 snowflakes 4-ft or smaller. Almond will price and email to council to get purchased before January 31st. Not to exceed \$12,000.

- 6. Next Regular Council Meeting is 7 p.m. Tues., Feb. 11, 2025 in Badin Town Hall.

Badin will host Stanly County COG meeting Feb. 25. Ward suggested asking Robin Gross of Alcoa to present program. Council consensus to have the meeting at the Badin Inn.

COUNCIL COMMENTS:

Ward said the museum started taking down the 25 Year Club pictures in Badin Conference Center. Gutters need to be cleaned at conference center. Ward asked about Cheoah/Tallassee streets repair. Almond said scope of work was expected to start in January. Council discussed options if the project estimate is too high. Almond said council awarded the contract the contract. Rife requested Almond seek an ETA and invite them to a meeting to present.

Rife asked if we have an update from NCDOT about Falls Road parking. Almond said no. Rife also said we need to schedule a Planning Board meeting to pick a new chairman.

Huntley said the council needs to meet with Badin Waterfront Park contractors to get financials discussed. Almond and Huntley will sort out scheduling for that meeting.
